2018 VIOLATIONS COMMITTEE REPORT

The Board strongly believes that educating and seeking voluntary compliance will better serve the public interest. Therefore, before pursuing punitive enforcement, corrective and rehabilitative actions will be taken. A summary of investigations is presented below.

Case #18001

Complaint: Registered Forester accused of Fraud and Deceit by private landowner. **Results:** Complaint was settled.

Case #18002

Complaint: Registered Forester accused of Fraud and Deceit by private landowner and Registered Forester. **Results:** Registered forester was found guilty of Fraud and Deceit which resulted in the surrendering his license.

Case #18003

Complaint: Registered Forester was accused of Other misconduct by private landowner. **Results:** Complaint dismissed for lack of probable cause.

Case #18004

Complaint: Timber buyer/logger was accused of practicing Forestry without a license. **Results:** Complaint was settled

William B. Tomlin, RF #0848, agreed to settle a disciplinary complaint charging that he committed fraud by failing to deliver payment for timber agreed upon in a contract with a landowner. The board ordered a penalty of \$4,000.00. Mr. Tomlin refused to pay the settlement and voluntarily surrendered his license to the board on 06/27/18.

SOUTHEASTERN FORESTER REGISTRATION BOARDS MEET Joe Roberson, AL State Board Chair; James Johnson, GA State Board Chair;

The 25th annual meeting of ASBORF (Association of Southeastern Boards of Registration for Foresters) was held in South Carolina this past August. This might be a new group to some of you, but its primary functions are to share information and collaborate where possible. Laws and rules for professional forester registration vary by state but at the core is the goal to: maintain a high educational requirement, hold foresters accountable for their work offered to the public, and to maintain high ethical stands for the profession.

There are fifteen states that have some form of licensure for foresters. Of these fifteen, six in the southeast saw advantages to forming an association with other boards and ASBORF was formed in 1993. The charter members include: Alabama, Arkansas, Georgia, Mississippi, North Carolina and South Carolina. Since there is no other association of states' forester boards, West Virginia requested inclusion into ASBORF at this meeting, and they were accepted. Although the Society of American Foresters (SAF) aren't "members" per se, they participate at each meeting due to the close relationship most state's rules and regulations have with them. SAF accredited curriculums at our Universities are typically the required majors for most states' registration rules and this ensures a baseline education. Most states also require continuing education for registered foresters and the SAF's Continuing Forester Education rules and process are used to ensure consistency.

States typically require forester candidates seeking state licensure to take an exam to show proficiency. Most of the southern states with registration mandates have a state-specific exam but two states utilize the SAF certified forester exam (coupled with a short state-specific exam).

The SAF presented information about some options they are exploring to track CFE credits at the national level and collaborating with ASBORF might make this a useful tool for some state boards to utilized with their respective state registered forester programs.

ASBORE will have a booth at the 2019 SAE National convention in Louisville, Kentucky. Plan to stop in and further this discussion.

A lot of remarks were made regarding the article on the Board of Foresters Seal in the summer newsletter, some positive and some negative. The seal and its many symbols was created when the Board was established in 1957. I would have loved the opportunity to be in the room when the newly appointed board members were considering what exactly does forestry mean, and how best to represent forestry in a seal that would live on as long as the Board exist.

The Board's seal is modeled from the Chinese design of perpetuity and the symbols within the seal represent many things. The factory represents industry, the trees represent the forestry sources, the stream represents the water source, the chemistry apparatus represents science, the Aladdin's lamp represents the magic of knowledge, the silhouette represents the State of Alabama, and the gearwheel represents the wheel of progress.
