Governor Appoints Al Lyons to Board of Registration for Foresters

On January 26, Governor Riley appointed Alan D. Lyons, RF #1413, to replace outgoing board member Leh Bass. Al was one of the three Registered Foresters recommended by the SAF to Governor Riley to serve on the Board. Upon hearing that he had been chosen to serve on the Board, Al said he was "humbled by this honor and looks forward to working with the other Board members to protect Alabama's forest resources and the profession he loves."

Al, a native of Mobile grew up in Tennessee. He received a B.S. in Forest Resource Management and an M.S. in forestry, both from the University of Tennessee in Knoxville. In 1994 he received an M.S. in Environmental Management from Samford University in Birmingham.

Al began his forestry career with Kimberly-Clark Corporation as a Research Forester. With K-C, he managed a genetic tree improvement and tree nursery program. During this time, he led research and development efforts and was a representative to cooperative research programs at both Auburn University and North Carolina State University. He later went on to positions as a Silviculturist, Environmental Manager and Area Land Manager. He has been a steward of East Central Alabama Forest for over 23 years. Since this land has been sold to U. S. Alliance and later to Hancock Timber Resource Group investors, he has continued to be involved with its managemnt. He currently serves as Manager of Silviculture and Stewardship for the Southern Division of Hancock Forest Management. The Southern Division currently manages 960,000 acres of forestland in ten states for institutional investors.

One of Al's passions is the stewardship of Alabama's

forest resources. In 1998, he served on the Outstanding Alabama Water (OAW) Workgroup formed by the Alabama Department of Environmental Management. This workgroup consisted of numerous environmental and business stakeholders that worked together to clarify interpretation of OAW criteria. He has also worked to educate the general public on forest

Board Describes Core Curriculum for Foresters

The Alabama State Board of Registration for Foresters is charged by the Alabama Code with ensuring that the citizens of the state are well-served by the forestry profession. The Board attempts to achieve that end by, among other duties, licensing only those who meet the professional standards for Foresters set out by the Code. The Code states that, in order to be allowed to take the licensing examination, applicants must have a Bachelor's or higher degree from an SAF accredited forestry program or from a program and curriculum that meets the Board's approval. As the forestry profession has evolved, required courses have changed and many applicants come before the Board today with educational backgrounds that test the Board's ability to judge their adequacy. Increasingly, we are faced with applicants whose undergraduate degrees are not in forestry, but who have earned a Master's degree or doctorate in forestry from an accredited school. The concern is that many of these programs require that the student complete only a minimal course of study in basic forestry. The Board is reluctant to license and present to the public as a competent professional forester someone who has not com-

pleted a mensuration or silviculture course, for instance. These are not entirely new situations and past Boards have dealt with them in the way they felt was in the spirit of the law and which treated both the profession and the public fairly. The makeup of the Registration Board changes annually, however, and consistency has sometimes been difficult to maintain. Although records of Board actions are kept, sometimes the only reference we have at hand is Pam's memory. It's better than most, but still hard to cite as precedent for a subsequent Board decision.

There will always be gray areas and there is no "one size fits all" solution. The current Board has attempted to set some minimal curriculum standards for applicants which might clarify who is and who is not eligible to take the licensing exam and ultimately become a professional forester. Drawing on SAF accreditation standards and the curricula of several prominent forestry programs, we have devised a "core" forestry curriculum with which to judge applicants. The list is not all inclusive, but does contain what we

judged to be subject areas central to the practice of forestry. Applicants who have not earned a Bachelor's degree in forestry from an accredited forestry program are asked to submit a transcript for the Board's review. That transcript is then compared to the list of "core" courses and a decision is made as to whether or not the applicant has satisfied the basic educational requirements for taking the licensing exam. Substitutions for listed courses are possible. For example, Agricultural Economics course might be substituted for Forest Economics or a Systematic Botany course for Dendrology. The list is not all inclusive by any means, but does cover what we feel are the basic educational requirements for professional forestry. We cannot judge course rigor or compare courses taught at one university to courses taught at another. In the end, subjective judgments will still be required of the Board members, but we feel this list will impose a measure of consistency for us and future Boards. We invite your comments on this process.

Other courses that are frequently required or offered include tree physiology, watershed ecology, surveying, silvics, wildlife management, harvesting, prescribed fire or fire ecology, forest recreation, wood properties or forest products, forest taxation and remote sensing (GIS and/or aerial photography).

General coursework should include general chemistry, biology, genetics, computer science and/or applications, mathematics, statistics, and technical writing.

"Core" Courses Common to Most SAF Accredited Forestry
Degree Programs and Guidelines for licensing in Alabama

Mensuration/Forest	Sampling theory, tree and stand measurements, log rules,
Measurements	cruising techniques
Dendrology	Forest tree identification, characteristics and uses/values
Silviculture	Manipulation of forests to produce desired outcomes/products
Forest Economics	NPV, IRR, LEV's, etc., forest investment analysis, costbenefit calculations, etc.
Forest Management	Forest regulation, silvicultural decisions and impacts on forest structure, growth, composition, profitability, etc.
Forest Pathology/ Forest Health	Insects, diseases, protection, sanitation, salvage
Forest Policy	Laws, regulations, history and policy development
Forest Ecology	Interactions between forest components, site-species relationships, watersheds, aspects, slope, habitat typing
Forest Soils	Productivity, site-species relationships, erodability

Clarification of Category Two Continuing Education Hours

There has been some confusion over the awarding of Category 2 Continuing Forestry Education Credits over the past several years. The guidelines for continuing education contained in the Administrative Rules for the State Board of Registration for Foresters, in Chapter 380-X-6-.04, state that Category 2 credits may be earned for the "development, preparation, and presentation of forestry or forestry-related course work, in an instructional capacity such as described in Category 1, which require effort beyond the general scope of the individual's normal duties or job description. Credit accrues at the rate of two contact hours for each hour of presentation."

The phrases in bold type are critical to understanding the intent of the 1992 Board decision which created this rule. Category 1 credits are earned for attendance of organized course work on forestry or forestry related topics presented at a **professional** level and must meet the following five measures: (1) It constitutes an organized program of learning which contributes directly to the **professional** competency of the registered forester; (2) It deals primarily with matter directly related to the practice of forestry, to the professional responsibility or ethical obligations of Foresters; (3) It is conducted by Foresters or individuals who have special education, training, or experience by reason of which they can be considered experts in the sub-

ject matter of the program; (4) It is conducted in a setting physically suitable to the educational objectives; and (5) The subject matter is applicable to Foresters in general. Category 2 credits, then, can only be earned for preparation and presentation of coursework which meets Category 1 standards, coursework intended for professional Foresters and presented at a professional level. This, in the opinion of this and past Boards, does not encompass class presentations to elementary or secondary school students, Boy Scouts, 4-H clubs, etc. Nor does it allow for credits for presentations to adult groups such as civic clubs or garden clubs. In addition, a registered Forester whose normal job duties include instruction in some forestry or forestry related fields cannot receive CFE's in Category 2 for doing so. For instance, the safety officer for a forestry firm cannot receive Category 2 credits for teaching on-the-job safety courses, nor can a university professor receive Category 2 credits for teaching forestry courses as part of his ordinary duties. Because the standards for Category 2 hours are relatively high and because the time and degree of difficulty required for preparation of professional coursework, two credit hours are awarded for each hour of presentation.
