## What is the Practice of Forestry?

Due to increasing technology and the action of other professional boards to better describe their areas of practice, Rhett Johnson, Chairman, has led the Board in working on a Policy detailing what the Practice of Forestry as defined in the Alabama Code might include. The Board is asking for comments on this change and additions to the list.

Practices specific to the profession of forestry include but are not necessarily limited to:

*Inventory*-Work appropriate to variability of resource inventoried and purpose of the inventory; useful estimates of volumes, products, values, acreages, etc.; used in both management and procurement; accuracy and credibility of sample important.

Management Planning-Concepts considered include Sustained Yield, Multiple Use, Soil/Water Conser-vation, Wildlife Habitat, Species Choice, All-aged vs Even Aged, Ecosystem Level, Regeneration, Costs/ Revenues, IRRs, NPVs, T&E Species Protection, BMPs, Recreation, Soil and Land Productivity.

Forest Typing/Stand Delineation-Criteria include species, age class, land use history, soil and moisture gradients, management impacts, administrative boundaries. May involve the use of photography, GIS, GPS, mapping programs, and acreage calculations.

Timber Harvest Planning-Considerations include harvest layout, scale, scheduling, equipment, roads and decks, resource protection, sale administration, boundary recovery, selection marking, merchandising, GPS, bmps, T&E regulations, site protection, regeneration.

Regeneration-Considerations include artificial versus natural; all-aged, uneven-aged, and even-aged systems, species selection, spacing, site preparation, planting, seedling type, release, soil and water conservation, costshare, seedbed preparation.

Intermediate Stand Management-Considerations include stocking levels, forest health and vigor, hazard reduction, prescribed fire, wildlife management, property line maintenance, roads, crossings, bmps, competition control, and invasive species control.

Timber Appraisal-Considerations include knowledge of the cost approach, income approach, and market/sales approach to value; local markets, regional markets, merchandising, species variations, access, loggability, bmps, etc.

Selling Timber-Considerations include all of the prior mentioned practices, agency for landowners, discernment of landowner objectives, boundary recovery/maintenance, selection marking, bmps, mapping, marketing, road building/maintenance, T&E species considerations, harvesting practices.

# **Board to Consider Requiring Use** of "RF" Designation

The Board has been petitioned to consider making the use of the R.F. designation mandatory after your signatures on letters, maps, reports and other similar documents and after your names on all advertisements, business cards, and other communications seen by the public. Essentially, wherever you use your name in conjunction with forestry matters, "RF" needs to follow. This is for the express purpose of denoting that you are registered and hold a valid license to practice forestry.

In the past, the Board has strongly admonished foresters to use their RF designations as it makes it much easier for the public to KNOW they are dealing with a qualified registered forester, not another member of the forestry community. Requiring the use of the RF designation will take effort on the part of every forester and on the Board (which will be challenged to enforce the policy with limited manpower).

The Board will receive comments on this proposed change until their October 2006 meeting. Please express your views by email or letter to any Board Member. Also, test how this change will affect you by beginning to use your RF designation more diligently. Remind yourself and each other of this important pronouncement of our professional status.

The following directives are taken directly from the State of Alabama Roster of Registered Foresters:

Persons registered under Alabama Law and licensed under 34-12, 1975 Code of Alabama are authorized and encouraged to insert the abbreviation R.F. (meaning Registered Forester) after their signature on letters, maps, reports, and other similar documents for the express purpose of denoting they are registered and hold a valid license.

For signatures Only:

John Doe, R.F.

Official title (ex. Timber Buyer, Consulting Forester, District Manager, etc.)

For certifications Only:

John Doe, R.F.

Alabama License No.....

The Board strongly recommends and urges all Registered Foresters to frame and display their licenses and to place their official impression seals on all documents requiring their signatures.

### **Foresters and Forestry Vendors**

The State of Alabama requires that anyone practicing forestry, offering to practice forestry, offering forestry advice, or advertising themselves as a forester in the state must be licensed by the state to do so. There are few exceptions to the law: foresters employed by the federal or state governments and working only on public lands, foresters working for educational institutions and involved in teaching forestry who give their forestry advice to the public for free, and foresters working under the direct supervision of a licensed (i.e. registered) forester. The intent of the law is to protect the interests of the public in the state, similar to the intent of the laws that license realtors, appraisers, surveyors, lawyers, doctors and other professionals. To provide this assurance, the Alabama Legislature in 1975 created the Alabama State Board of Registration for Foresters to develop standards for licensing, rules governing those licensed, and rules to protect the public from unethical behavior by licensed foresters or non-licensed persons acting as foresters.

In order to be licensed to practice forestry in Alabama, foresters must have graduated from a four year accredited forestry program or from a program otherwise approved by the Board, have two years of forestry experience, and pass a examination administered by the Board. In addition, registered foresters must complete continuing professional forestry education coursework annually to maintain their licenses. These measures assure the public that the registered forester has the requisite professional education, relevant experience, and keeps current through continuous education. Unethical behavior is investigated by the Board and disciplinary action taken if warranted.

The Board of Registration for Foresters also monitors non-registered persons who violate the licensing law. Anyone not registered as a forester but who practices forestry, except for the exemptions noted above, is guilty of a misdemeanor and may be subject to prosecution and fines. The Attorney General's office provides prosecutorial assistance in these instances, if prosecution is necessary. The Board's typical response to a complaint against a non-licensed person practicing forestry illegally is to notify the offender of the law and request that they "cease and desist" those activities. Failure to do so will result in the Board turning the case over to the Attorney General.

There is an important distinction to be made between foresters and forest contractors or vendors.

## **Board Reviewing and Revising Forestry Laws and Rules**

The Board recently reviewed the 1975 Code of Alabama Section 34-12 and all Administrative Rules of the Board. Since it was a Sunset year, the Board hoped to make several needed changes to the law concerning the printed roster, license renewal and expiration dates, and other administrative items.

The Sunset Committee examined the Board, approved it to continue, and made two changes:

- A web posting of the Roster of Registered Foresters will be allowed along with a printed version.
- Currently registered foresters will become exempt from continuing education requirements after age 65.

The first change was requested by the Board. The second change was proposed by the Alabama legislature to coincide with other Board's continuing education requirements. None of the other amendments proposed by the Board were considered, so those changes will have to be pursued by other means.

In addition to amending the Code of Alabama, the Board has been petitioned to make the following changes to their Administrative Rules:

- 1. Clarification that the Board can approve the curriculum of a person with an advanced forestry degree, but no undergraduate forestry degree, if it meets their strict guidelines.
- 2. Clarification of continuing education requirements in several areas.
- 3. A Policy that describes the core curriculum for forestry the Board is accepting.
- 4. Clarification that the offering of standing timber for sale involves the application of forestry.
- 5. A policy requiring a notarized statement from a registered forester who is allowing a non-registered forester to work under their license.

The Board is also considering rule changes that:

- 1. Require registered foresters to display their RF designation after their signature on forestry documents and after their name on all communication to the public such as advertisements, business cards, etc.
- 2. A detailed description of what the Practice of Forestry may include.

These last two changes are under review at this time and comments are being solicited. (See other newsletter articles.) If you have any comment about them, please write or email any Board member.

On a recent visit to Auburn University, Euan Mason, a forest researcher from New Zealand, said, "A professional forester is capable of thinking critically and communicating effectively about all ways in which people interact with trees. Often, the most valued contribution a forester can make is to identify for decision-makers the social, economic, and environmental consequences of alternative actions within forest ecosystem. A variety of skills is required, and foresters integrate in-depth knowledge of "hard" sciences (particularly biology), ecology, business management, sociology, engineering, mathematics and statistics.

... This is followed by studies of more complicated decision-making in forests containing different forest types and a variety of desired uses, such as conservation, recreation, wildlife preservation and wood production. Education for professional foresters includes studies of why and how decisions are made, not simply what should be done in a particular circumstance. Consequently, foresters should be able to practice effective and wise forestry anywhere in the world, in response to any specified goals."

Forestry practice is defined in the Alabama Code as "any professional service such as consultation, investigation, evaluation, planning or responsible supervision as interpreted by the Board of any forestry activities in connection with any public or private lands wherein the public welfare and property are concerned or involved when the professional service requires the application of forestry principles and data." The Board has historically interpreted this as including silvicultural decision-making, forestry prescriptions, recovering land lines, planning and conducting timber sales, inventory and evaluation of standing timber, and general forest management and management planning. Once a forestry practice is prescribed, the Board has interpreted the law to exclude from the licensing requirement those who perform some of the technical services, such as logging, tree planting, herbicide application, site preparation, or prescribed burning. Note that these forestry contractors cannot legally give a landowner any forestry advice.

Not only does the Board of Registration for Foresters have the responsibilities of protecting the public and policing the profession, it also has the responsibility of enforcing the law and will do so when infractions are detected.

### **SUMMARY OF BOARD ENFORCEMENT ACTIVITIES**

The philosophy of the Board is that educating and seeking voluntary compliance best serve the public interest. Therefore enforcement actions first seek to correct and rehabilitate before pursuing punitive measures. A summary of ongoing complaint investigations is presented below in tabular format.

- 1. Practice or offer to practice the profession of forestry without being registered or exempted.
- 2. Use in connection with name or otherwise assume, use, or advertise any title or description tending to convey the impression that one is a registered forester, without being registered or exempted in accordance with Code of Alabama 1975 Chapter 12, s34-12.
- 3. Present or attempt to use as one's own the license of another; or any person who shall give any false or forged evidence of any kind to the board or any member thereof in obtaining a license.
- 4. Attempt to use an expired or revoked license.
- 5. Violate any of the provisions of Code of Alabama 1975 Chapter 12, s34-12.
