WARMLY REMEMBERING *David Holley*



James David Holley, Alabama Registered Forester #586, died on July 1, 2019 at the age of 74 as a result of an accident moving a deer stand to accommodate a logging operation on Family lands. During his career, James worked at Boise Cascade in Jackson, Alabama from 1979 til 2004 and was charged with many wood procurement duties including buying local stumpage for the sawmill, the paper mill, the Frisco City wood yard as well as delivering roundwood down the river systems from Bridgeport and Scottsboro wood yards via river tugs, usually controlled by Parker Towing. He was frequently referred to as Colonel by his associates at Boise as a nod to his rank in the Army Reserve 926th Engineering Group. Best known by his friends and co-workers as a man of great integrity, vast humor and immense appetite, literally, his business activities usually centered around the social aspect of a meal while conducting affairs. He was known for breaking up a meeting at 11:00 to go eat. To this day, Boise woodland employees still eat at 11:00 as a result. His duties also included managing company owned lands east of the Alabama River.

After leaving Boise, James continued his forestry career in private practice before accepting a position in 2007 with Timbervest, LLC, now Domain Timber Advisors, LLC, located in Atlanta, Georgia, where he was responsible for the purchase of land and timbered tracts in both Alabama and Mississippi until he retired in May of this year.

His affable style made him easy to approach with problems when guidance was needed, and he was a resource of contact information when outside help was required. He never refused to stop what he was doing and assisted with a project when requested. His work ethic was never questioned, and he was known as a good person all around.

Many was the time he would be seen belly laughing himself to tears, much to the amusement of those around. Guilty of assigning nicknames specific only to him and his coworkers, there was never a missed opportunity at mischief directed at someone, while proving extremely capable of deflecting mischief directed his way. He was loved and will be missed by all his co-workers. Those who knew him and read this can't help but smile as memories of him resurface. His laughter and mirth will be missed. He leaves behind his wife of 52 - years, Carolyn, daughters Kimberly Felts (Marty) and Caroline Schultz (Brandon), sons Jeffrey (Laura) and Jason (Kari), and 15 grandchildren. Rest in Peace Colonel. Those of us who knew you best are sure that you are in God's presence.

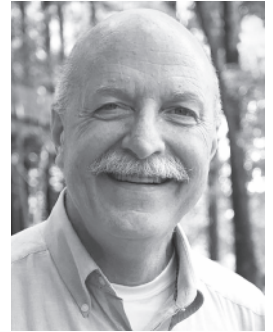

Governor Ivy Appoints New Board Member DANIEL P. NORMAN

Daniel P. Norman, RF, was appointed to the Alabama Board of Registration for Foresters by Governor Kay Ivey on August 15, 2019 to replace resigning member Victoria Lockhart.



As a new member of the Alabama State Board of Registration for Foresters, I feel honored to have been selected and appointed to serve in this position. I am a native of Birmingham and attended Auburn University, where I earned a B.S. in Forestry. The first job in my forestry career was a procurement forester and logging crew manager at a small private saw mill. I was prepared for the dendrology, mapping, inventory estimation and measurement, but the personnel management, accounting, logistics, mechanics and heavy equipment operations (or Business Fundamentals 101) were course studies with interactive lab exercises that greatly enhanced my degree. The School of Forestry had introduced these business attributes and had prepared me to be flexible and observant, allowing me to manage situations and learn. My education by participation continued from that beginning through work as a consultant and then to a forest operations supervisor for an integrated pulp and paper mill. The skills learned with the logging, road construction and site preparation equipment enabled me to assist with management of 350,000 acres of timberland through road maintenance and construction planning, internal and contract site prep, coordination of seedling logistics, chemical and fertilization application. Land management activities were rewarding and the management of other values of the land asset (SMZs, riparian areas, special sites, recreation) were meaningful and expanded my thoughts of our profession.

The track of my career always migrated back to harvesting, timber sales and procurement. The skills learned here included a different form of inventory measurement and management. Measurements I learned in school, but terms, on-time deliveries and capital cost, resurrected from business management and marketing courses secreted away in memory while I enjoyed more worldly delights like blackberry, gallberry and greenbriers on a cruise lines and drip torches during burning activities. A new appreciation for the logistics learned in the past and a strong appreciation for cost control, inventory control, transportation and handling expense. I also learned some interesting and useful bits of wood technology like weight change from water loss once the tree is severed from the stump an important piece of reconciling your inventory, or is that accounting, and the conversion factors for wood as you create chips for the pulp process. By the way, there is another whole book on chipping, chip size, uniformity of the chip, how you chip it, where you chip, but I have digressed, something old foresters do or is it all foresters, the point was that I moved to sales and purchasing and have done that for most my time in the business. However, the barrage of points above were to indicate that there are always opportunities to learn and call it education or experience it provides a continuous stream of new ideas for broadening your base of knowledge and skills.

I recently spent time assisting in the management of client properties and operations for our business expansion. The property consisted of pine plantation investments in Southern Brazil, with assets like the Southeast, mostly southern yellow pine, the mills produce plywood, MDF, paper, and molding, and the harvesting and delivery system are very much like ours. The greatest difference is cut-to-length processing in the woods. The language is different, it's several thousand miles away, but the process is still essentially forest management and sales through stumpage purchases and contract deliveries. There are trained foresters, business professionals and well informed, active mill owners and managers. The experience gained throughout my earlier career assisted with most of the operational challenges and I found the people associated with forestry in Brazil to be much the same as those in the U.S., friendly, engaging and always talking about how good or bad it is and the weather, especially when it's raining.

I have been a part of the registered foresters' community for over four decades, serving a multitude of roles through those years. Those roles have exposed the broad field of manufacturing that the forestry profession represents from solid wood products, engineered wood, pulp and paper, energy, textiles, transportation and even food. Similarly, the practices that a forester can perform have a broad range of specialties including but not limited to seedling nurseries, genetics, consulting landowners, silvicultural applications, harvesting, transportation, timber sales, timber purchasing, urban forestry, recreation; the possibilities are ever increasing. I enjoy being a forester and telling the story when people ask what a forester does. We work in an interesting and demanding profession based on science and solid business and financial practices. I hope to share this as a member of the Alabama State Board of Registration for Foresters.

The 2019 Annual Meeting of ASBORF was held August 28-30, 2019 at the Conference Center at the Natchez Grand Hotel in Historic Natchez, MS.

The Technical Sessions were held August 29, 2019. Topics included: license renewals, audits, exemptions and reciprocity agreements. These sessions provided opportunities for discussions on similarities and differences between states, as well as opportunities for improvements.
